The the end of the year is approaching, a time for parties, toasts, as well as evaluations of what happened during 2018, identification of the limitations, of the weak points. It is essential to include in these closures future plans, new challenges, improvements to be made, in order to continue betting on satis-

fying our customers with a quality citrus fruit, attractive color, good flavour and innocuous.

For the 2018 harvest, we estimate that we would export 37 thousand tons. However, the actual volumes exported reached 30 thousand tons. There were several reasons and of a different nature, internal and external to the companies, most of them not predictable. We also had satisfactions such as the good behavior of Uruguayan fruit in relation to quarantine diseases. As well as the good arrival of our mandarines to new markets such as China.

At the moment we are collecting, with the producers, the estimated volumes to be harvested in the next season. Although it is very early, a normal harvest is glimpsed in this sense. In the first months we will inform you about the adjustments. As always we have the uncertainty of the climate during the summer, the period where fruit yields and sizes are defined.

With this bulletin we say goodbye until 2019 where we will resume, prior the first shipments, the communication with you by this means.
