#### 2018 season development

Since the delivery of the last Bulletin, Clemend'or, Clemenvilla, Salustiana, Navel, White Murcott y Valencia Midknight arrivals have been completed. Meanwhile the harvest of Valencia Late, Ortanique and Lemon it's really advanced.

Weather conditions during August has had more precipitations than expected, nevertheless it didn't cause delay in harvest. In September rainfall was normal in the plantions while a punctual episode of hail with no consecuences on the fields of Paysandú and Salto.

For the closure of the harvest it is expected the arrival of a shipment on week 41 with Lemon, Nadorcott and Valencia Late.

#### WEATHER **CONDITIONS**

The characteristics of the temperature for the winter made it the coldest of the last 10 years with a negative anomaly of 2°C throughout the country.

Rainfall for the June-July-August divided the country into north and south. In the north they were between 100 and 160mm above average while in the south they were close to norma

#### Prospects for the end of the harvest

Temperatures and precipitations are expected above the normal values resulting from the "El Niño" phenomenon.

It is important to highlight the commitment assumed in the continuous improvement of each member of the Group; this is manifested with the fulfillment of the required quality standards and is possible with the involvment assumed by the URUD'OR team and all its member producers and Packers.

This year we will implement our internal audits during the summer, both to the farms and to the packing houses; in the latter case as a way to begin to comply with the new requirements requested by version 8 of BRC.

## Code of Labour Practices

From the first week of August, the Code of Labour Practices is available to all members of the URUD'OR S.A group. It was updated by our Technical Department and has been received by all the staff. It is also available on our website in a bilingual format for those who want to access it.

## Colombia market opens up


The Colombian Agricultural Institute (ICA) announced the guidelines for the importation of mandarins, oranges and grapefruit from Uruguay.


Its main requirements are:
